## VI. Homeowner Affidavit

I hereby certify the Plumbing work described on this permit application shall be installed **by myself in my own home** in which I am living or about to occupy. All work shall be installed in accordance with the State Plumbing Code and shall **not be enclosed, covered up**, or put into operation until it has been **inspected** and **approved** by the City Plumbing Inspector. I will cooperate with the City Plumbing Inspector and assume the responsibility to arrange for necessary inspections.

## VII. Instructions for Completing Application

GENERAL: Plumbing work shall not be started until the Plumbing Permit has been issued by the City of Rochester Hills Building Department. All installations shall be in conformance with the State Plumbing Code. **No work shall be concealed until it has been inspected.**

When ready for inspection, contact the 24-hour inspection line at the number listed above. Inspections called in after 8:00 a.m. will be scheduled for the following business day. The **address, permit number** and **type of inspection** are required when requesting an inspection.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELLED PERMITS CANNOT BE REFUNDED OR REINSTATED.**
