



Photographer's Annual Permit Form 2019

The Rochester Hills Museum at Van Hoosen Farm includes five historic buildings and the Stoney Creek School, a children's garden, and sixteen acres of historic grounds. The entire site is listed on the National Register of Historic Places. Our mission is to interpret, preserve, and collect the history of the greater Rochester area for present and future generations. Your annual permit fee helps the museum care for our grounds, preserve our historic buildings, develop innovative programs, and conserve archival materials.

Your annual permit fee gives you permission to use our grounds for photography during **calendar year 2019**, except during Museum special events and weddings that have contracted for exclusive use of our grounds. Restrooms are available for your use whenever staff is on site.

Please call ahead to be sure the grounds are available and check-in at the Dairy Barn Staff door when you arrive. You should have your Museum lanyard with 2019 permit attached and visible when you are on the grounds.

The Rochester Hills Museum reserves the right to monitor appropriate use of the property and props for photographs on our grounds. Please do not climb or sit on any of the historic walls. No alcohol or smoking allowed.

Thank you for enjoying the Rochester Hills Museum site - 1840 Van Hoosen Farmhouse, 1927 Dairy Barn, 1850 Red House, 1848 Schoolhouse, 1911 Milk House, 1927 Calf Barn and 1927 Bull Barn as well as sixteen acres of gardens and rolling lawn bordered by Stoney Creek.

This is a beautiful site that we want to share with you.

The Rochester Hills Museum at Van Hoosen Farm requires photographers pay a modest fee to help support the Museum's operation. This site is listed on the National Register of Historic Places and our community has invested substantial funds to acquire and preserve this location.

In order to provide exceptional customer service to guests and users, this fee is required to help regulate who is on the site and to coordinate your use in regards to other events.

2019 Fee Guidelines:

- * **\$50 per day** – daily permits can be purchased at the Museum's office in the Dairy Barn.
- * **\$250 annual permit** – annual permits can be purchased via Official Payments at www.rochesterhills.org/museum or in person at the Dairy Barn via cash or check made out to the City of Rochester Hills. Annual permit valid for the **calendar year**.
- * **\$75 per hour for wedding photography – reservation required.**
- * All photographers must wear the distinctive Museum identification badge while on the site.
- * **Fees are required regardless of whether the Museum is staffed or open to the public**—Please put check in Museum mailbox at corner of Van Hoosen Rd. and Runyon Rd., when no staff is on site.
- * Photo sessions may not be allowed when special events are in progress. Please call the Museum to coordinate your photography session.
- * The Rochester Hills Museum reserves the right to monitor appropriate use of the property and props for photographs on the grounds. **Please do not sit or climb on any of the historic walls.** No smoking is allowed anywhere on this site.
- * Alcohol is prohibited on Museum property.
- * The interior of any building is not available for photography.
- * Bathrooms are available for use when the Museum is staffed.
