

## 2015 CITY MILLAGES

City taxes are billed on the Winter Tax Statement.

<b>Operating Millages</b>	
<b>City General Fund (Charter) -</b> Voters established Rochester Hills as a Charter City in May, 1984. The City can levy up to 5.0 mills of property tax for Governmental operations. The maximum allowable millage rate is capped by the Headlee Amendment at 3.9100 mills.	2.0275
<b>Local Street I (Voted) -</b> 10 year new millage of .3545 mills approved by the voters on 08/3/10 is authorized through 2019 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at .3542 mills.	0.3542
<b>Local Street II (Voted) -</b> 7 year new millage of .4855 mills approved by the voters on 11/6/12 is authorized through 2019 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at .4851 mills.	0.4851
<b>Local Street III (Voted) -</b> 10 year new millage of .2972 mills approved by the voters on 8/5/14 is authorized through 2019 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at .2969 mills.	0.2969
<b>Fire Fund (Charter - Amended by voters on 11/04/14)</b> The City can levy up to 3.0 mills for funding of the Fire Department. The maximum allowable millage rate is capped by the Headlee Amendment at 2.9976 mills.	2.7000
<b>Special Police I (Voted) -</b> 10 year millage of 1.2083 mills approved by the voters on 8/7/12 is authorized through 2023 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at 1.2073 mills.	1.2073
<b>Special Police II (Voted) -</b> 10 year millage of up to 2.5 mills approved by the voters on 8/7/12 is authorized through 2023 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at 2.4980 mills.	1.6036
<b>Pathway (Voted) -</b> 20 year renewal of .1858 mills approved by the voters on 11/7/06 is authorized through 2025 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at .1856 mills.	0.1856
<b>Rochester-Avon Recreation Authority Operating (Voted) -</b> 10 year renewal plus additional millage totalling .1950 mills approved by the voters on 8/8/06 is authorized through 2015 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at .1948 mills.	0.1948
<b>Older Persons' Commission Operating (Voted) -</b> 10 year renewal of .2403 mills approved by the voters on 8/3/10 is authorized through 2021 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at .2401 mills.	0.2401
<b>Older Persons' Commission Transportation (Voted) -</b> 10 year renewal plus additional millage totalling .10 mills approved by the voters on 11/3/15 is authorized through 2024 tax year.	0.1000
<b>Library Operating - (Charter)</b> Pursuant to Public Act 164 of 1877, as amended, City shall levy up to 1 mill for library purposes. The maximum allowable millage rate is capped by the Headlee Amendment at .7816 mills.	0.7816
<b>Debt Millages</b>	
<b>Chapter 20 Drain Debt -</b> Unlimited millage authorized by State law - Chapter 20 Drain Code.	0.0426
<b>Older Persons' Commission Building Debt (Voted) -</b> Unlimited millage approved in 2000 by voters for repayment of bond debt to build new older persons center. Authorized through 2020 tax year. (Original amount \$9,770,000; Bond refunding in 2010.)	0.2412
