<p>City General Fund (Charter) - Voters established Rochester Hills as a Charter City in May, 1984. The City can levy up to 5.0 mills of property tax for Governmental operations. The maximum allowable millage rate is capped by the Headlee Amendment at 3.7751 mills.</p>	2.6582
<p>Local Street I (Voted) - 10 year new millage of .3470 mills approved by the voters on 08/3/10 is authorized through 2019 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at .3418 mills.</p>	0.3418
<p>Local Street II (Voted) - 7 year new millage of .4753 mills approved by the voters on 11/6/12 is authorized through 2019 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at .4683 mills.</p>	0.4683
<p>Local Street III (Voted) - 5 year new millage of .2908 mills approved by the voters on 8/5/14 is authorized through 2019 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at .2864 mills.</p>	0.2864
<p>Fire Fund (Charter - Amended by voters on 11/04/14) The City can levy up to 3.0 mills for funding of the Fire Department. The maximum allowable millage rate is capped by the Headlee Amendment at 2.8942 mills.</p>	2.7000
<p>Special Police I (Voted) - 10 year millage of 1.2083 mills approved by the voters on 8/7/12 is authorized through 2023 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at 1.1655 mills.</p>	1.1655
<p>Special Police II (Voted) - 10 year millage of up to 2.5 mills approved by the voters on 8/7/12 is authorized through 2023 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at 2.4118 mills.</p>	1.1640
<p>Pathway (Voted) - 20 year renewal of .1858 mills approved by the voters on 11/7/06 is authorized through 2025 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at .1789 mills.</p>	0.1789
<p>Rochester-Avon Recreation Authority Operating (Voted) - 10 year renewal plus additional millage totalling .1948 mills approved by the voters on 11/3/15 is authorized through 2025 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at .1878 mills.</p>	0.1878
<p>Older Persons' Commission Operating (Voted) - 10 year renewal of .2403 mills approved by the voters on 8/3/10 is authorized through 2021 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at .2334 mills.</p>	0.2316
<p>Older Persons' Commission Transportation (Voted) - 10 year renewal plus additional millage totalling .10 mills approved by the voters on 11/3/15 is authorized through 2024 tax year. The maximum allowable millage rate is capped by the Headlee Amendment at .0963 mills.</p>	0.0963
<p>Library Operating - (Charter) Pursuant to Public Act 164 of 1877, as amended, City shall levy up to 1 mill for library purposes. The maximum allowable millage rate is capped by the Headlee Amendment at .7545 mills.</p>	0.7545

<p>Chapter 20 Drain Debt - Unlimited millage authorized by State law - Chapter 20 Drain Code.</p>	0.0372
<p>Older Persons' Commission Building Debt (Voted) - Unlimited millage approved in 2000 by voters for repayment of bond debt to build new older persons center. Authorized through 2020 tax year. (Original amount \$9,770,000; Bond refunding in 2010.)</p>	0.1900
